





हीरालाल यादव विद्यालय की समूह की परिकल्पना वर्ष 1990 में ही बाबू हीरालाल यादव जी द्वारा बालिका शिक्षा के विकास हेतु तत्कालीन सरकार को यह सुझाव दिया गया कि जिन विकास खण्डों में बालिका विद्यालय नही है वहाँ बालिका विद्यालय की स्थापना की जाय। सरकार द्वारा यह प्रस्ताव स्वीकार किया गया और लखनऊ जनपद के सरोजनी नगर विधानसभा में दो बालिका विद्यालय स्थापित किये गये। विद्यालयों की शृंखला की प्रथम कड़ी हीरालाल यादव बालिका इण्टर कॉलेज की स्थापना 1997 में 221 बालिकाओं की शिक्षा प्रारम्भ करने के साथ हुई। वह पल और आज शिक्षा के क्षेत्र में एक ऐसा शुभारम्भ कि 2001 में बालिका डिग्री कालेज, 2005 में लॉ कालेज, 2015 में पब्लिक स्कूल 2018 में हीरालाल मेमोरियल ट्रस्ट ऑफ एजूकेशन में संचालित B-Sc (Ag.) पाठ्यक्रम तथा हीरालाल पब्लिक स्कूल सरोजनी नगर, हीरालाल यादव प्राथमिक विद्यालय की स्थापना के साथ कुल 07 विद्यालयों की शृंखला विद्यालय समूह द्वारा संचालित है। बाबू हीरालाल यादवजी के सपनों का बीज पुष्पित एवं पल्लवित होते हुए वट वृक्ष का रूप धारण कर रहा है।

इस विचार धारा को जीवन्त रूप देने के लिए संस्था ने ग्रामीण क्षेत्र के बच्चों को वर्तमान वैश्विक परिवेश में दृढ़ता से स्थापित करने के लिए अन्तः प्रतिस्पर्द्धात्मक रूप से तैयार करने हेतु "हीरालाल यादव लॉ कॉलेज" की 2005 में स्थापना की।

## **Eligibility of Admission in LL.B. (Three Years)**

- 1. To get admission in LL.B. (Three Years) a Candidate must have passed 10+2+3 examination from any recognized Board/University of India with minimum 45% marks for General, 42% for OBC & 40% for SC/ST candidates.
- 2. Candidates of other states need to submit Character/Domicile Certificate from concerned authorities.
- 3. After getting admission, a candidates must secure 66% of class attendance as per regulation of Bar Council of India & Lucknow University Lucknow.
- 4. There is no upper age limit for admission in LL.B. (Three Years) / (Integrated)
- 5. Law College has following rules to :
  - a. admission may be cancelled by giving any reason.
  - b. to amend rules & regulation of admission of college.
  - c. decision of principal is final in admission.
  - d. candidates serving in public/private sector must submit N.O.C. from their respective department.

**Warning:** Any candidate found giving wrong information/facts will be liable to cancel his/her admission & statutory actions may be initiated, if required.

# REGULATIONS OF LL.B. (THREE YEARS) COURSE CIRCULATED BY LUCKNOW UNIVERSITY

- 1. A candidate will be eligible for admission to LL.B. (three year) Class; if he/she has obtained bachelor's degree, recognized by Lucknow University Lucknow with 10+2+3 system and has secured not less than 45% marks at graduation Level (General/OBC), 40% marks of SC/ST candidates, 45% marks at graduation Level (General), 42% marks of OBC, 40% marks SC/ST candidates.
- 2. As per the ordinance for Admission to LL.B. (three Years) from the Session 2002-03 and onwards, issued by the University of Lucknow, 80% of the sanctioned seats be filled up Lucknow University remaining 20% seats are available for admission for Graduates of other university. Any seats remaining vacant, shall be filled by the Graduates of Lucknow University in order of merit.
- 3. If the marks obtained at the Graduation examination of two or more candidates are the same, in that case, the percentage of marks secured by the candidates at the intermediate examination will be the determining factor of merit for admission.
- 4. If the marks obtained at the High School or equivalent examination of two or more candidates are reach same, in that case, the candidates who is senior in age will get preference in the merit list.
- 5. Period in between the year of passing, qualifying examination and the year of application for admission to LL.B class shall be treated as a gap and 02% marks shall be deducted for each gay year from he percentage of qualifying degree.

6. For a candidate passing Post-Graduate Examination in continuation of the qualifying examination, the time of Post Graduate Examination of two Years will not treated as



# Workshop on Legal research and Writing

Skills for the Legal Research is an indispensable quality of a good lawyer, jurist, academician. No matter what career option a person may opt after Law School, legal researching skills forms the core of that career choice. Keeping this in Heeralal Yadav Law College organises workshop on 'Legal Research and Writing.' Workshop was taken by Advocate Shubhanshi Singh, alumnai, Symbiosis Law School, who has several feathers to her cap when it comes to Paper Presentation and Publication. The session taken by her was highly informative. She educated students about the nuances related to framing of research questions, framing a hypothesis, testing a hypothesis and several other intricacies about researching and writing a quality research paper.

# Legal Aid Camp, 3 December, 2022

Legal aid and awareness is an elementary step towards legal empowerment. In furtherance of the above goal, Legal Aid Committee of Heeralal Yadav Law College organised 'A Legal Aid and Awareness Camp'. This camp was an attempt to impart critical knowledge of legal provisions, in order to empower people to realise their rights. The event started with a speech from Devesh Tripathi, student of BA LL.B. (H) who explained the Rights & Government schemes to realise those right, related to women. Anshika Trivedi, student of LL.B., recited a self-composed poem, to instil sensitivity among masses towards female gender. Shortly after her, Sanya Singh, student of BA LL.B. (H), made people aware of the consequences of unequal treatment towards women. Siraj Ansari, student of BA LL.B. (H) continued the session with introduction of the concept of Right to Information. He explained the concept and touched upon the relevance and procedure of filing a RTI. Simultaneously, legal aid part of the camp took place where number of people sought advice about sereral legal issues like, seeking bail, property disputer, issues related to pension. On the spot applications were drafted for people, wherever required. Queries of 52 people were resolved in the legal aid part of the camp. The session was concluded by a door to door activity where our students educated people about the importance of menstrual hygiene. They burst several myths about mensuration as a process. A number of positives emerged out of the Legal Aid and Awareness Camp. The Committee Members, Rohit, Asha, Anuj, atima, Suyash, Kirti, Fayyaj, Sakshi and Navneet were beyond elated to get such an optimistic response.

# Nature and Scheme of LL.B. (Integrated) Final Year Programme

This course is approved and recognized by Bar Council of India, Rules under sections (7(h) and (1), (241) (e) (iii) and (iii-a) and 49 (1), (a g) and (d) of the Advocate Act, 1961.

It is a combinations of B.A. and LL.B. Course. Its purpose is to educate and train candidates for taking up legal profession and pursue other avenue wherein Law subjects are either compulsory or optional. The entire course is spread over 10 Semesters, each of six months, generally starting on 1st July and 1st Jan. It has been divided into two parts which are as follows:

Part-I:- 2Year core programme of pre-law students, and

Part-II:- 3 Year programme for professional training in law.

#### **ELIGIBILITY CRITERIA FOR ADMISSION**

This course is open to those who have passed intermediate or equivalent (10+2) or 11+1) examination from any recognized Board with minimum given % of marks as decided by the University and Bar Council of India from time to time. Candidates shall be admitted on the basis of merit which shall be judged by their performance in the qualifying examination and also on the result of test and interview held by the admission committee of the college.

Rule 6 (1) of part IV of the Bar Council of India, rules down the following "The Part-I Examination should be conducted as to be called University Examination. A student who has passed Part-I of the law course shall be eligible for enrolment in the final year of the three year Degree Course in Arts, Social Science etc. supplicate for the B.A. degree. A student who has completed three years of the 5 year course in Law is eligible to get a degree from the University on passing such examination on conducted by the same University which is equivalent to B.A. (Law), but such degree shall not entitle the student to be enrolled as an Advocate. The enrolment will be possible after completing remaining two year course which includes practical training also.



#### NOTE

The candidates who are appearing for the qualifying examination and expect to complete the eligibility requirements can also appear at the entrance test but their candidature will be considered only when they provide documentary evidence of eligibility requirement.

#### **HOURS OF STUDY**

Teaching, including tutorials, lectures and clinical studies shall be for six hours per day. Class room lectures shall not be less than 24 hours per week. For each prescribed paper there shall be lecture classes for three hours and one hour of tutorial work per week.

#### **ATTENDANCE**

Every student shall be required to have a minimum attendance of 75% of lectures in each of the subjects as also at tutorials, moot courts and practical training course.

#### **EXAMINATION**

The examination shall ordinarily be held at the end of every semester. Suitable of subjects for the period of one year or six months, as the case may be, shall be made by the university, and will be intimated by the "bar Council". The students are advised not to bring any books/notes/mobile to college during the examination period.




#### **LIBRARY**

The college has rich and growing library under the charge of qualified librarians. Adequate number of law books, National and Internationals Law Journals available there. It remains open for used by the students for about 8 hours per day.

#### **EXTRA CURRICULAR ACTIVITIES**

Beside the practical training prescribed by the 'Bar Council', the college arranges debates, most courts, group discussion, quiz competitions and lectures on different subjects by experts for the exposures and development of students. The college also encourages for healthy hobbies and fosters cultural programme.



#### HOSTEL

Only limited hostel facility is at present available for girls. Private accommodation is available both for boy and girls.





#### **TRANSPORT**

Limited college transport is available on main route.

#### **OTHER FACILITIES**

The College has well equipped computer lab and other research library which can be used by students. It is also proposed to give special training to the students in English speaking and other language on reasonable charges so that they may secure placement elsewhere also. A 'Legal Aid Clinic and Forensic Laboratory' are also being established with special cells like blood, poison, ballistic evidence, hand writing and finger prints etc.



The legal aid clinic will provide training to the students in entire working of Law with the help of professional senior lawyers and experts from forensic science Laboratory. It would also provide free help to the poor, destitute and needy sections of the society. Arrangements are also being made to give special coaching to senior students by the faculty, so that they may take up legal and judicial service competitions after completing their course.



#### **MEDICAL**

A medical room with the basic facilities including a dental chair, a physician and visiting specialists are available.

#### **PAYMENT OF FEES**

Fees due for each semester is to be paid on time by given dates. If fee is not paid by that date, late payment fee shall be charged. Name of the student shall be struck off, if fees is not paid by the last day of the month by which the payment is due. He/She shall be allowed for re-admission on payment of arrears including tuition fee and late payment fee.





The college shall run according to the rules of 'Bar Council of India' and 'Lucknow University', Lucknow under Self-Financing Scheme.

The College lays full emphasis upon discipline. Students are expected to follow all rules and regulations.

They are not permitted to leave the campus during college hours without the permission of the Manager/Principal.

If any student indulge in and act of indiscipline, he/she shall incur the risk of rustication. The verdict of the Manager/Principal regarding punishment is final. Uses of mobile phones are forbidden in the college and fine is also being charged for the same.





Uniform is compulsory for all students. They are not permitted to enter the college campus without uniform. The details of uniforms are as follows:

#### **SUMMER**

1. Boy: Black Pant, White Shirt, College Belt, Black Shoes and Black Socks.

2. Girls: White Salwar, White Kurta, Black Dupatta to Cover Chest and head, Black Shoes and Black Socks.

#### **WINTER**

For boy & Girls-same dress with black blazer/sweater.

- 3. Timing of Law College is 09:00 a.m. to 04:00 p.m. on all working days (Monday to Saturday).
- 4. Candidates seeking reservation & weightage must attach relevant documents issued by competent authorities.
- 5. All the documents related to educational qualification & certificates must be enclosed with admission form.
- 6. Candidates are instructed to participate in all the Co-curricular & Extra-curricular activities organized by Law College.
